- Reference any specific comments to a page or section within the proposal document.
- Identify aspects of the proposals that you support, or do not support. Explain your reasons for disagreeing with the content of the proposal and suggest alternatives
- Highlight any information that may be inaccurate and provide a reference to assist with further editing.

Please note that your submission will become part of the public record and will be available to anyone who requests a copy unless you specifically request otherwise.

After all submissions received have been carefully considered, a final proposal document will be prepared and forwarded to the Minister for Climate, Environment and Water for consideration together with a detailed analysis of submissions received.


